## SUNCOAST USBC WOMEN'S 12TH ANNUAL CITY TOURNAMENT <br> OFFICIAL TOURNAMENT RULES

1. USBC rules and regulations shall govern this tournament unless otherwise specified in these tournament rules. The tournament Director shall decide any questions not covered by these rules.
2. Only Adult USBC sanctioned FEMALE members (Summer 2021 / Current) are eligible to participate in this tournament.
3. This will be a handicap tournament with optional scratch events. Both doubles bowlers must pay the scratch event fee.
a) Handicap is $90 \%$ of 210 based on the following:
1) Highest USBC 2021-2022 Winter/Summer yearbook average of 21 games or more.
2) If no 2021-2022 Winter/Summer yearbook average of 21 games or more, bowler will use their highest December $31^{\text {st }}$, 2022, mid-year average of 21 games or more. You MUST provide current standings sheet as verification.
3) Bowlers who do not have an average as established in 1) or 2 ) above will bowl scratch.
b) The ten-pin rule is not in effect for this tournament.
4. The tournament shall consist of a three-game singles event and a three game doubles event. Bowlers may bowl in the singles, doubles, or both events.
5. All pre-registered bowlers must check in 30 minutes prior to squad time.
